Terms of use

The partner must carefully read and understand the content of all MSRIse documents downloaded at <https://msrise.com/>. This agreement is considered to be the part of the original agreement concluded between the client and the company's management, and having full legal force. If the client agrees with the conditions listed in this document, as well as on <https://msrise.com/> website, and undertakes to comply with them, he / she needs to become the company's full-fledged partner by purchasing one of the proposed investment package on the minimum amount of \$100.

1. Acquisition of the company's investment package is optional, but it is required for the partner to participate in a multi-channel marketing program, receive awards and gain benefits.

I am aware that as MSRIse partner:

- A. I have the right to sell investment packages belonging to the company in accordance with these terms and conditions.
 - B. I have the right to register individuals and legal entities with the company.
 - C. After completing the activation procedures and buying one of the investment packages, I am entitled to receive rewards in accordance with the multi-channel marketing program.
2. A potential partner / client must be at least 18 years old and have all the rights to enter into this agreement according to the terms of the "Indian Treaty Law", if applicable.
 3. The partner agrees with the submitted investment proposal, all types of bonuses, affiliate and career programs, and all services in accordance with the conditions described in the company's official agreement.

4. The partner agrees that he / she will be solely responsible for paying all expenses incurred by him / her. The partner is aware that he / she does not consider MSRIse as an employee for the purposes of governmental and local taxation. The company should not deduct taxes from my bonuses, accruals of profits, if there are any. With any incoming and outgoing payments of partners, organizations, the company does not deduct taxes. In another case, the company has the right to withhold a commission from 0% to 2% for withdrawing or transferring funds on the company's website. The partner cannot create any legal relations with respect to the company and does not have any rights to this. The partner cannot represent or act on its behalf.
5. The partner has carefully read and undertakes to comply with the terms of MSRIse policy and procedure agreement, investment plans and MSRIse service terms, which are the part of these terms and conditions (these documents are hereinafter referred to as the “agreement”). The partner understands that he / she must be honest in legal and financial terms and abide by the terms of the agreement in order to have the right to get MSRIse bonuses and profits. The partner understands that MSRIse documents, investment plans, affiliate remuneration and terms of service are subject to change at the sole discretion of the company. The partner undertakes to comply with all the amendments. Amendment notices must be posted on <https://msrise.com/>. The further cooperation of the partner with MSRIse and subsequent profit, bonuses, rewards means that he / she accepts all amendments without exception. The partner also has to continue the purchase of investment packages.
6. The partner must not transfer any personal account rights without prior written consent from the company. Any attempt to transfer the rights without MSRIse written consent entitles the company to challenge the effect of the agreement, and in some cases may lead to the rupture of relations with the partner.

7. Any promises, statements, proposals and other messages not indicated in the agreement are null and void.
8. If the partner intends to file a lawsuit against the company for any action or omission to act related or arising from the terms of the agreements, such decision must be implemented within one year from the date of the alleged conduct being the cause to the claim. The failure to take action within a specified time frame makes all claims regarding MSRIse action or omission to act invalid. The partner waives all claims with other statute of limitations applied.
9. The partner gives the company the right to use his / her personal data, videos, photos, personal stories, and refuses all claims for remuneration for their use.
10. The electronic "Agreement" file is equal to its original copy in all respects.
11. The partners or customers of all countries placing an offer to purchase MSRIse investment packages are required to purchase one of the investment packages in order to receive a partner reward.
12. The company does not accept payment in cash under any circumstances. If someone makes a payment in cash, he / she does it at his / her own risk, and the company is not under any circumstances responsible for such unauthorized payments in cash.
13. Financial incentives for a partner are carried out only through an increase in the volume of his / her business, which is also the rule of law formulated by the company and introduced in the investment plan and multi-channel marketing. The company does not guarantee any financial incentives for the partner only due to his / her connection to MSRIse, acceptance of investment and partnership conditions, downloaded on <https://msrise.com/> website.
14. After registering a user, he / she will be notified via an e-mail containing a notification of the receipt of all necessary documents, status, as well as a valid username and email. The user's login and email must be indicated in all the partner's transactions, as well as correspondence with MSRIse technical support.

15. Under no circumstances the company contacts a user without notifying his / her username and email.
16. The partner must share the company values, ensure integrity and abide by etiquette among participants, maintain good relationships with partners, friends and clients.
17. The user must always behave and act appropriately to support the partner status of this well-known and leading investment company.
18. The partner should not force, induce to action or mislead anyone with false statements / promises to join the company or purchase an investment package.
19. MSRIse is not responsible for any promises and guarantees given by the partner to anyone if they contradict the approved business plans and the terms of the company's investment profits, downloaded on <https://msrise.com/>. For this reason, the user must familiarize himself / herself with the documents downloaded on <https://msrise.com/> website, as well as with brochures and company notices, adhere to all the company's terms and conditions. If the partner is found guilty of non-compliance with the conditions of the company's documents, then the cooperation with him / her will be terminated without prejudice to the company's rights and in accordance with the law.
20. The partner guarantees that all information provided to the company is true and entered correctly. The requests to change information can be considered up to 30 days.
21. The company reserves the right to reject the registration request of any user at its own discretion.
22. The partner must behave honestly and openly towards other MSRIse partners, users and customers.
23. The partner is fully aware of and shares all the company's conditions along with its rules.

24. The partner understands that being a non-staff user, he / she is not the company's representative or employee. For this reason, the partner has no right to create any legal relationship with respect to MSRIse or to act on its behalf.
25. The partner acknowledges that he / she has not been given any guarantees or promises by MSRIse employees or a senior partner regarding the income that can be obtained only on the basis of the initial investment made by him / her. However, the partner understands that he / she will be entitled to income, which depends on the amount of his / her business, carried out in accordance with the company's terms.
26. The partner undertakes not to promote the business of other companies in the office, premises, conference halls or in any other places where company events take place.
